## Fundraising Committee:

Dennis Nichols reviewed the minutes from the September 27, 2022 Fundraising and Event Committee meeting. Outreach to new and existing donors on a regular basis along with uncovering potential new donors will be a priority. Some suggested avenues for new donors were graduates of Growing with Books, Chamber of Commerce members and other public service organizations. Development of Associate dues paying members was also discussed. The next public event, Coming Together for Education, is being planned for this coming April or May.

#### Finance Committee:

Lincoln Kretchmar reviewed the minutes of the Finance Committee meeting held on November 2, 2022. He highlighted the investment portfolio and the Financial Statements as of this date. BCET received \$25,000 from Beaver County – Recovery Act and \$45,000 from Lincoln Learning, (30,000 for Mini Grants and 15,000 for Growing with Books).

Lincoln also discussed whether BCET should do a full audit. The Audit committee will meet with Ken Herman, the BCET accountant, to discuss the benefit/need of a full audit and the cost.

### Marketing Committee:

Lincoln Kretchmar reviewed the social media numbers for the year. He also told the board that we were moving on from Trailblaze and will be looking at other companies for proposals for marketing the Trust. Suggested that an intern might be the way to go instead of a firm.

#### **New Business:**

Executive Director, Jamie Connelly acknowledge the receipt of \$1000 from Tusca Ridge for a gardening mini grant. Received 33 applications for mini grants. 30 were awarded. 9 Story walks were granted and 4 Steam walks.

Victor Raskovsky, thanked Mark Breedlove for his, many, many years of service. The entire board concurred.
